Adjudications

Only new directors will have class adjudications. Directors with a performance piece must rate students for class placement in ballet, jazz and modern according to the guidelines.

The ratings must be completed before you come for adjudication. Adjudicators must approve your students' class ratings.

Beginners are welcome to observe classes for a nonrefundable \$20 fee, which allows admittance to the non-public areas of the Culture Center. They will receive a dance festival booklet and security pass.

- All groups for adjudication must be ready one hour prior to your scheduled time.
